This is because the leaves are a sustainable source and the bark is not. The oil has a sweet, fresh & lemony aroma and blends wonderfully with other essential oils. Commonly used in the pharmaceutical & perfumery world for its aroma & its ability to soothe muscles, aches & pains.
